MA in Comparative Jurisprudence

This department was established at the beginning of the academic year 2009-2010 and the number of study hours for obtaining a master's degree is 33 hours, within two tracks:

The first: the thesis track: where the student studies (24) credit hours of the plan, and prepares a thesis (9) hours.

Second: The Comprehensive Path: where the student studies (33) credit hours, then after successfully completing the courses, he takes a comprehensive examination to measure his competence.

Fees

First: Bachelor's degree

The fees for a bachelor's degree in jurisprudence and its principles are (20) Jordanian dinars per hour.

The student pays a semester fee that includes the services provided at the university in the amount of:

The first and second semester (260) dinars Summer semester (200) dinars

Second: Masters:

The fees for a master's hour in comparative jurisprudence are 75 Jordanian dinars per hour.

The Bachelor's plan in the Faculty of Sharia, which has been approved by the Accreditation Commission, is distinguished as a varied plan rich in multiple legal subjects, according to the following educational competencies:

1. The Glorious Qur'an and its sciences: students learn the rules and art of recitation, memorizing parts of the Glorious Qur'an. The student is committed to memorizing by taking into account the provisions of recitation. He/she also studies the subjects of the sciences of the Qur'an, interpretation, the miracles of the Qur'an, the Qur'anic stories, and interpretation of the verses of rulings.

2. The Noble Hadith and its sciences: the student studies the biography of the Prophet, the sciences of hadith, memorizes some of the noble hadiths with their interpretation and explanation, learns about their rulings, and the guidance of the Prophet, may God bless him and grant him peace, in literature and manuscripts.

3.Islamic belief: the student studies the true Islamic belief, gets to know the various Islamic groups, and is taught subjects related to dialogue and fighting fanaticism and extremism.

4.Fiqh: the student studies many subjects, starting with the introduction to fiqh, then the rulings of acts of worship. He/she studies emerging issues in worship, a course in transactions, theory of the contract, and learns the provisions of contemporary financial transactions.

5.Personal status, penalties and judiciary: the student studies the rulings of marriage and divorce and the provisions related to them in terms of dowry, alimony, waiting period, and breast-feeding, as well as the issues of inheritance and wills. In the field of penalties, the student learns the rulings of punishment and retribution. The student in this field studies the Fiqh of the judiciary and the principles of trials.

Arabic language: the student studies the basics of 6.the Arabic language, writing and expression, and grammatical applications in the Glorious Qur'an and the Sunnah of the Prophet.
